AFFIDAVIT OF L. R. SEWELL

Before me, C. M. Galbreath, a Notary Public in and for said County, in said State, personally appeared L. R. Swell, who, being first duly sworn by me says as follows:

That he knew and was well and intimately acquainted with all the Moore children who signed that certain deed to Hixie Moore, on February 17th, 1940. That there were seven children in all, three boys and four girls namely, L. C. Moore, J. O. Moore, C. E. Moore, Othelia Moore Pilkerton, Alvania Moore, Lethia Moore Cordell, and Evilla Moore. That Othelia Moore Pilkerton, died about twenty-five years ago and left surviving her only two children, Wesley Pilkerton and Fenny Pilkerton. That J. O. Moore died in 1924, and left surviving him eight children, five boys and three girls, namely, Felix Moore, Lewis Moore, Horace Moore, Russell Moore, C. E. Moore, and Anna Lee Moore Wyatt, Blanch Moore, Curtis, Maxine Moore Kimel.
