The southwest quarter and the South half of the southeast quarter and the Northwest quarter of the southeast quarter, and the Southeast quarter of the northwest quarter of Section 19; and the South half of Section 30, and the southwest quarter of the northwest quarter of Section 30; and the Northwest quarter and the East Half of the Northeast quarter of Section 31, all in Township 21, Range 1 West; also the East Half of the Northeast quarter of Section 36, and the East Half of the Southeast quarter, and the Southeast quarter of the Northeast quarter of Section 25, all in Township 21, Range 2 West, situated in Shelby County, Alabama.
