TO HAVE AND TO HOLD to the said A. W. Vaughan and Harriett S. Vaughan, their heirs and assigns forever.

And said Shelby Building and Investment Company, a corporation, does for itself and for its successors and assigns, covenant with the said A. W. Vaughan and Harriett S. Vaughan, their heirs and assigns, that it is lawfully seized in fee simple of said premises; that they are free from all encumbrances; that it has a good right to sell and convey the same as aforesaid; that it will and its successors and assigns, warrant and defend the same to the said A.
