

## Deed of Relinquishment

KNOW ALL MEN BY THESE PRESENTS That the Alabama State Commission of Forestry, an Agency of the State of Alabama duly vested by law ( An Act of the Legislature of Alabama, No. 635, Acts of 1927, p. 725, approved September 6, 1927) with the care, jurisdiction and control of State Lands of the status of the lands hereby conveyed, and further authorized by law (Sec. 989, Code of Alabama of 1923, as amended by the Legislature of Alabama, Act No. 161, approved March 2, 1937) to exchange such lands for others of equal value and do such things as may be necessary to give full effect to such provisions of the law, for and in consideration of the conveyance by the United States to the State of Alabama under the provisions of the Act of Congress dated June 14, 1926 (44 Stat. 741), of the following described lands, all referred to the Huntsville Meridian, -

does hereby relinquish, remise, release, quitclaim and convey, under the provisions of the said Act of Congress and of the said Acts of the Legislature of Alabama, the following described lands, all referred to the Huntsville Meridian, -
