KNOW ALL MEN BY THESE PRESENTS:

That Whereas, on 6th day of May 1929, the Probate Court of Shelby County rendered a decree for the sale of lands hereinafter described and conveyed, for the payment of State and County taxes due from J.A.Skein the owner of said lands, and for the payment of the fees, costs, and expenses of and under said decree, and the sale had in execution thereof.

And Whereas, the refter, to-wit, on the 17th day of June, 1929, under and in pursuance of said decree said lands were regularly offered for sale by the Tax collector of Shelby County for said taxes, fees, costs and expenses, and no person having bid a sufficient sum for said lands to pay the same, said lands were bid in for the State for the sum of said taxes, fees, costs and expenses.

And Whereas, the time allowed by law for the redemptinn of said lands has elapsed since said sale, and the same not having been redeemed, the title thereto under said sale is still in been the State. And Whereas, said lands having/entered upon the books of the State Land Commissioner of the State of Alabama, with the approval of the Governor, has fixed the price of said land, and asvertained that the sum of Seventy eight and no/100 (\$78.00) dollars is sufficient to cover and satisfy all claims of the State and County againsy said lands for or on account of taxes, interest, fees, and comsts, and officers' fees which were due upon or have accrued against said lands, as provided for by law.

And Whereas, application has been made to the State Land Commissioner of the State of Alabama by Claude Prown to purchase said lands, and said sum of Seventy eight and no/100 (\$78.00) dollars therefor has been paid into the State Treasury.

Now Therefore, The State Land Commissioner of the State of Alabama, by virtue of and in accordance with the authority in him vested by law, with the approval of the Governor of Alabama, and in consideration of the premises above set out, has this day granted, bargained, sold, and conveyed, and by the se presents does grant, bargain, sell and convey unto the said Claude Brown, without warranty or covenant of any kind on the part of the State, express or implied, all right and title of the State of Alabama in and to said lands, described as follows:

Arkwright, lying and being situate in said County and State, to have and to hold the same, the said right&title and of the State in the lands aforesaid, unto Claude Brown and his heirs and assigns forever.
