KNOW ALL MEN BY THE SE PRESENTS:

That Whereas, on 11th day of May A. D. 1936, the Probate Court of Shelby Clounty rendered a decree for the sale of lands hereinafter described and conveyed, for the payment of State and County taxes then due from J.I.McClendon the owner of said lands, and for the payment of the fees, costs and expenses of and under said decree, and the sale had in execution thereof.

Now Therefore, The State Land Commissioner of the State of Alabama, by virtue of and in accordance with the authority in him vested by law, with the approval of the Governor of Alabama, and in consideration of the premises above set out, has this day granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the said Sarah Viola Hatcher, without warranty or covenant of any kind on the part of the State, express or implied, all right and title of the State of Alabama in and by said lands, described as follows:

SW4 of SW4 ex. 1 A. in SW corner, Section 25, Township 19, Range 3 W

lying and being situate in said County and State, to have and to hold the same, the said right and title of the State in the lands aforesaid, iunto Sarah Viola Hatcher, and her heirs and assigns forever.
