## Transmission Line Permit

Mims for and in consideration of the sum of One Dollars (\$1.00) to us in hand paid by Alabama Power Company, a corporation, the receipt whereof is acknowledged, do hereby grant to said Alabama Power Company, its successors and assigns, the right to construct, operate and maintain its lines of poles and towers and appliances necessary in connection therewith, as located by the final location survey heretofore made by said Company for the transmission of electric power with the right to string thereon from time to time electric power and telephone wires and the right to permit other corporations and persons to attach wires to said poles and towers upon, over and across the following described lands situated in Shelby County, Alabama:

Begin at a point in the North line of SW of NW Sec. 29, Tp 19 R 1 East which point is 165 feet west of the Northeast corner of SWH of NWH thence south 264 feet thence East 165 feet to the East line of SW to of NW thence south along Such east line to the center line of such East line of SW of NW thence at a right angle, west to the right of way of the Power line of Alabama Power Company, thence Northerly along such right of way to the South line of the Florida Short Route Highway right of way thence Northeasterly along such highway right of way to a point which is 165 feet west of the East line of NW tof NW thence East parallel with such East line to the point of beginning containing 19.5 acres more or less in Westa of NW4 Sec. 29 Tp 19 Range 1 East.

Together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including the right of ingress and egress to and from said lines; and also the right to cut and keep clear all teees, and to keep clear other obsturctions, that may injure or endanger said lines.
