Beginning at a point on the South line of the NW $\frac{1}{4}$  of SE $\frac{1}{4}$ , Section 5, Township 22 South, Range 3 West, said beginning point being 720 feet East of the Southwest corner of said quarter quarter Section, thence East along South line 185 feet, thence North 460 feet, thence West 185 feet, thence South 460 feet to the point of beginning excepting the right of way of the Southern Railroad. This lot contains two acres more or less. Excepting therefrom, however, and reserving unto grantor, its successors and assigns, all minerals located in said land together with all the usual and customary mining rights and privileges in connection therewith, and also the right and privilege of using the surface of said land for the purpose of constructing, operating, maintaining and using thereover roadways and telephone, telegraph and power lines.
