Earle, deceased, all its right, title and interest in and to the following lends, lying and being in the County of Shelby, State of Alabama, and particularly described as follows, to-wit:

The north half of the hortheast quarter or Fractions A and B in Section 24, Township 22, Range 2 west, situated in Shelby County, Alabama

This deed is executed for that it appears from said records that on August 1st, 1890, the Shelby Iron Company, an Alabama corporation, conveyed to the Alabama Coal & Iron Company, a New Jersey comporation, with other properties, certain lands located in Township 22 South, Talladega County, Alabama, said lands being erroneously described in said conveyance as being in Range 2 West; that the said lands are actually located in Range 2 East in said County, and have been continuously so assessed; that this quit claim deed is made for the purpose of correcting said error in the description as shown in said deed which is of record in deed book 70 at page 182 in the office of the Judge of Probate in Talladega County, Alabama, and in record book 14, at page 33 in the Probate Judge office of Shelby County Alabama.

That the Charter of said Alabama Coal & Iron Company was amended and the name of the Corporation changed to the Shelby Iron Company, a New Jersey Corporation; that the latter Company was subsequently dissolved and its properties conveyed to the present Shelby Iron Company of Alabama.
