

AFFIDAVIT

Before me the undersigned authority in and for said County in said State, personally appeared Mrs. Lula Lee Jones, who being first duly sworn on oath says that this affidavit relates to the North Half of the Southeast Quarter of Section 22, Township 21, Range 3 West, which lies North of a road recently built across said property, situated in Shelby County, Alabama. Affiant further says that Irvin M. Jones who was appointed executor of the estate of Joe S. Jones was a son of Joe S. Jones and was one and the same person as Milton Jones, and that said Irvin M. Jones, was the husband of affiant and who died on March 24, 1928, intestate. Affiant further says that the property herein described was never the homestead of R. H. Walker and that R. H. Walker, Sr., was one and the same person as R. H. Walker whose wife was M. F. Walker and who formerly owned the property herein described and conveyed the same to J. S. Jones, having purchased the same from the heirs of James H. Wilson, who died many years ago. Affiant further says that Irvin M. Jones paid all the debts of the estate of Joe S. Jones and that all of the debts of the estate of Irvin M. Jones, called Milton Jones in the probate records of Shelby County, Alabama, have been long since paid. Affiant further says that upon the death of Joe S. Jones affiant's husband took possession of the property herein described, having received it by will from his father, and that during the lifetime of Milton Jones said Milton Jones regularly assessed and paid the taxes on said property, used fire wood and rail timber and post timber from said land and that after the death of said Irvin M. Jones affiant and her children have been in continuous possession of said property, regularly assessing and paying the taxes on the same and that during the period of more than thirty years that affiant has known said property no one has had any possession or made any claim to said property except Joe S. Jones during his lifetime, Irvin M. Jones during his lifetime and affiant and her children since the death of said Irvin M. Jones. Affiant further says that Irvin M. Jones left surviving him as his only heirs, affiant, his widow, and Ulma Jones, who is now Mrs. Ulma Jones Harrison, Irene Jones, who is unmarried, and Mary Lee Jones, who is unmarried, and that said Irvin M. Jones left no other children or children of deceased children of his. All of said heirs being over the age of twenty-one years at this time and who are the same persons who have executed the deed to Robert Earle Williams and his wife, Vera Williams.
