KNOW ALL MEN BY THESE PRESENTS: That we, Nellie H. Johnson and husband, Joe Johnson, of said County and State, for and in consideration of One Dollar in hand paid to us by R. J. Mabry, the receipt whereof is hereby acknowledged, do hereby remise, release, quit claim and convey unto the said R. J. Mabry, all our right, title, interest and claim in and to the following described real estate, situate in the County of Shelby, State of Alabama, to-wit:

Beginning at the northwest corner of section 33, township 21 range 2 west, thence north along section line 980.5 feet, thence south 17 degrees 08' west 790.1 feet to the L & N R R Co. right of way, thence south 42 degrees 27' east-- 765.3 feet, thence north 62 degrees 44' east 224.2 feet, thence south 23 degrees 29' east 901.8 feet, thence north 73 degrees 11' east 249.3 feet to point "A", thence south 15 degrees 59' east 424 feet, thence south 25 degrees 43' east 245.9 feet to point of beginning of the property conveyed hereby, thence south 37 degrees 30' west 28.5 feet, thence south 13 degrees 04' east 211.2 feet, thence south 75 degrees 42' west 128.3 feet, thence south 7 degrees 50' east 477.1 feet, thence south 36 degrees 03' east 165.3 feet, thence north 78 degrees 45' east 173.5 feet, thence south 17 degrees 44' east 669.3 feet, thence north 84 degrees 48' east 1035.1 feet to Montgomery highway right of way, thence along said right of way north 15 degrees 02' west 1407 feet, thence north 18 degrees 38' west 364.8 feet along said right of way, thence south 70 degrees 45' west 1068.8 feet to point of beginning.
