paid, receipt of which is hereby acknowledged, the undesigned hereby grant(s), bargain(s), sell(s), convey(s) and warrant(s) to PLANTATION PIPE LINE COMPANY, A Delaware Corporation, its successors and assigns, a right-of wy and easement for the purpose of constructing, maintaining, operating, altering, repairing, removing, changing the siz of, and replacing pipe for the transportation as a common carrier for him of oil, crude petroleum and refined petroleum products or combinations thereof or similar thereto, natural and artificial gas, casinghear and natural gasoline and any other liquids or gases, the Grantee to have the right to select the route, under, upon, over and through the lands situate in the County of Shelby, State of Alabama, described as follows:

The undersigned vovenant to and with Grantee, successors and assigns, that the undersigned are the easement hreby granted.

The grantee, by the acceptanced hereof, agrees to bury the pipe lines so that they will not interfere with the cultivation of the lands, and also to pay any damage to crops, fences and timber, which may arise from laying, maintaining, operating or removing such pipe lines. Said damage, if not mutually agreed upon to be ascertained and determined by three disinterested persons; one to be appointed by the undersigned successors heirs, or assigns; one by the Grantee, its successors or assigns, and the third by the two-persons aforesaid, and the award of such three persons, or any two of them, shall be final and conclusive.

It is understood and acknowledged by the undersigned that the person securing this grant is without authority tomake any agreement in regard to the subject matter hereof, which is not expressed herein, and that no such agreement will be binding on the Grantee.
