FOR AND IN CONSIDERATION OF THE sum of Two and no/100 Dollars, to the undersigned Owner(s) paid, receipt of which is hereby acknowledged, the undersigned grant(s), bargains(s) sell(s) and Convey(s) and warrant(s) to PLANTATION PIPE LINE COMPANY, a Delaware Corporation, its successors and assigns a right-of-way and easement for the purpose of constructing, maintaining, operating, altering, repairing, removing, changing, the size of, and replaceing pipe for the transportation as a common carrier for hire of oil, crude setroleum and refined petroleum products or combinations thereof or similar thereto, natural and artifical gas, casinghead and natural gasoline and any other liquids or gases, the Grantee to have the right to select the rouge, under, upon, over and through the lands situate in the County of Shelby, State of Alabama described as follows:

SEA of NWA, Section 2, Township 19, Range 2 East, Shelby County, Alabama. with ingress and egress to and from the said right-of-way.

The Grantee, by the acceptance hereof, agrees to bury the pipe lines so that they will not interfere with the cultivation of the land and also to pay any damage to crops, fences and timber, which may arise from ascertained and determined by three disinterest persons; one to be appointed by the undersigned their succesors, heirs or assigns; one o by the Grantee, its successors or assigns, and the third by the two persons aforesaid, and the award of such three persons, or any two of them, shall be final and conclusive,

It is understood and acknowledged by the Undersigned that the person securing this grant is without authority to make any agreement in regard to the subject matter hereof which is not expressed hereink and that no such agreement will be binding on the Grantee.
