FOR AND IN CONSIDERATION OF the sum of Twnety and no/100 the undersigned owner(s)
paid, receipt of which is h reby acknowledged, the undersigned herebyrgrant(s), bargain(s), sell (s) convey \$s
and warrants(so to PLANTATION PIPE LINE COMPANY, A Delaware Corporation its successors and assigns a, right-
of way and easement for the purpose of constucting, maintaining, operating, altering, repairing, removing
changing the size of, and replacing pipe for the transportation as a common carrier for hire of oil, cruded
pretroleum and refined petroleum products or combinations thereof or similar thereto, natural and artificial
gas, casinghead and natural gasoline and any other liquids or gases, the Grantee to have the right to select
the rouge, under, upone, over and through the lands situate in the County of "helby, State of Alabama, described
as follows:

Whe of SEA of SEA Section 13, Township 2, Range 2 West, in Shelby County, Alabama.

with ingress and egress to and from the said right-of-way.

And also the right to lay, construct, maintain, operate, alter, repair, remove and replace,

at any time additional lines of pipe adjacent to and parallel with the lines above mentioned upon payment for

each additional line so laid, the consideration above mamed. Such additional lines shall be laid subject to the same rights and conditions as apply to the original line. It is provided that all pipe lines constructed under this grant shall be confined to a strip of ground thirty feet in width, the center line of which shall be the center line of the first pipe line herafter installed by Grantee over, upon, through, under and across said lands.

TO HAVE AND TO HOLD the said easements unto PLANTATION PIPE LINE COMTANY, its successors and

assigns, so long as a jpe line is maintained the eon.

The undersigned Grantors, their its, successors, heirs or assigns, reserve the right to

fully use and enjoy the said premises, except as the same may be necessary for the purposes herein granted.

The undersigned convenant to and with Grantee, successors and assigns, that the undersigned

is the owner(s) of the above described lands and has the right, title and capacity to convey the right-of-way and easement hereby granted.

The grantee, by the acceptance hereof, agrees to bury the pipe lines so that they will not

interfere with the cultivation of the land, and also to pay any damage to crops, fences, and timber, which may arise from laying, maintaining, operating or removing such pipe lines. Said damage, if not mutually agreed upon to be ascertained and determined may othree disinterested persons; one to be appointed by the undersigned, her successors, heirs or assigns; one by the Grante, its successors er assigns, and the third by the two persons aforesaid, and the award of such three persons, or any two of them, shall be final and conclusive. It is understood and acknowledged by the undersigned that the person securing this grant is

without authority to make any agreementiregarding to the subject matter hereof which is not expressed herein and that so such agreement shall be binding on the Grantee.
