OPTION FOR PURCHASE OF FARM WITH FUNDS LOANED BY THE UNTIED STATES OF AMERICA (LUMP SUM) (VENDOR TO FURNISH TITLE INSURANCE)

1. In consideration of the sum of One Dollars (\$1) in hand paid and other valuable considerations the receipt and sufficiency of which are hereby acknowledged, the undersigned (hereinafter called the "Seller"), who covenants that he is the owner therof, hereby, for himself and his heirs, executors, administrators, successors and assigns, offers and agrees to sell and convey to Jesse W. Barnes, or such other person as may be designated in his stead by the Regional Director of the Farm Security Administration of the Untied States Department of Agriculture for the region in which the land hereinafter described is located (hereinafter called the "Buyer"), and hereby grants to the said Buyer the exclusive and irrevocabel option and right to purchase, under the conditions hereinafter provided, the following-described lands, located in the County of Shelby, State of Alabama:

All that part of the south half of the north west quarter of Section 10, Township 21 Range 1 East except a strip 153 gards wide of even width across the north side of said eighty, which is being sold to Willie Stone; and the north east quarter of the south west quarter of said Section 10, Township 21, Range 1 East; containing in all 95 acres, more or less.

The title to said land is to be conveyed free and clear except for the following reservations, exceptions, and leases, and no others;

- 2. This option is given to enable the Buyer to obtain a loan from the United States acting by and through the Secretary of Agricultrue (hereinafter called the "Government"), pursuant to Title 1 of the Bankhead-Jones Farm Tenant Act, for the purchase of said lands.
 - 3. The Purchase price for said land s is the sum of \$2,000.00 for the tract as a whole.
- 4. The Seller agrees to deliver, without charge to the Buyer, a policy of mortgagee title insurance in favor of the Government issued by such company as the Government shall approve, in the amount of the purchase price of said property, and to comply with all the requirement of such company, including the furnishing of an abstract of title and continuation thereof where required, The Seller further agrees that except as herein provided all taxes, liens, encumbrances, or other interest, in third persons, will be satisfied, or discharged by him, induding stamp taxes and other exprense incidental to the preparation and execution of the deed and other evidences of title required by the Government. Upon failure of the Seller to furnish such policy of insurance within a reasonable time, the Buyer may procure such insurance intimich revents the cost thereof shall be deducted from the purchase price herein provided.
- 5. The Seller further agrees to convey said lands to the Buyer by general warranty deed (except where the law provides otherwise for conveyances by trustees, officers of courts, etc.) in the form manner, and at the time required by the Government, conveying to the Buyer, a valid, unencumbered, indefeasible fee simple title to said lands meeting all requirements of the Government; that the purchase price shall be paid at the time of recording such deed; that said lands, including improvements, shall be delivered in the same condition as they now are, customary use and wear excepted.
- 6. Taxes, water assessments, and other genreal and special assessments of whatsoever nature for the year in which the closing of title takes place shall be projected as of the date of th closing of title, it being expressly agreed that for the purpose of such proration the tax year shall be deemed to be the calendar year. If th closing of title shall occurd before the tax rate is fixed, the apportionment of taxes shall be on the basis of the tax rate for the next preceeding year applied to the latest assessed valuation.

- 8. This option may be exercised by the Buyer by mailing or telegraphing a notice of acceptance of the offer herein to W. J. Wheeler, at Wilsonville R F D # 2, in the city of Wilsonville, State of Alabama at any time while the offer herein shall remain in force. The offer herein shall be irrevocable for a period of three months from the date hereof, and shall remain in force therafter until terminated by the Seller.

- 9. Loss or damage to the property by fire or from other acts of God shall be at the risk of the Seller until the deed to the Buyer has been recorded, and in the event that such loss or damge occurs, the Buyer may, without liability, refuse to accept conveyance of title, or elect to accept conveyace of title, in which case there shall be an equitable adjustment of the purchase price.
