A part of SW<sup>1</sup><sub>4</sub> of NW<sup>1</sup><sub>4</sub> of section 4 township 22, Range 3 W as follows: Begin 70 yards East of SW corner of said 40 acres, Thence East 105 yds thence north 140 yds, thence West 175 yds thence South 70 yds Thence East 70 yds; thence south 70 yards to point of beginning.

Together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including the right of ingress and egress to and from said lines; and also the right to cut and keep clear all trees, and to keep clear other obstructions, that may injure or endanger said lines.
