NE4 of SW4 of section 4, township 24, range 15 East Less 3 acres.

Together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including the right of ingress and egress to and from said lines; and also the right to cut and keep clear all trees, and to keep clear other obstructions that may injure oriendanger said lines.
