

TRANSMISSION LINE PERMIT 46284

STATE OF ALABAMA,
COUNTY OF SHELBY.

We, Sam Scott and wife, Janie Scott, for and in consideration of the sum of One and no/100 Dollars (\$1.00) to us in hand paid by Alabama Power Company, a corporation, the receipt whereof is acknowledged, do hereby grant to said Alabama Power Company, its successors and assigns, the right to construct, operate and maintain its lines of poles and towers and appliances necessary in connection therewith, as located by the final location survey heretoforemade by said Company, for the transmission of electric power with the right to string thereon from time to time electric power and telephone wires and the right to permit other corporations and persons to attach wires to said poles and towers upon, over and across the following described lands situated in _____ County, Alabama:

Measure a distance from a stake from the Mayweather line a distance of 734 ft. running north on the Dogwood Road to a stake on the north Bank of the Main ditch, beginning at the above said stake running in a north east direction 175 ft., north west 270 ft., south west 175 ft., then south east to the point of beginning 270 ft. off of the fractional part of SE $\frac{1}{4}$ of SW $\frac{1}{4}$ of Section 16, Township 22, Range 3 west.

Together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including the right of ingress and egress to and from said lines; and also the right to cut and keep clear other obstructions, that may injure or endanger said lines.

TO HAVE AND TO HOLD the same to the said Company, its successors and assigns forever.
