Stevens, deceased, who departed this life on February 13, 1941, intestate, leaving as his sold heirs and next of kin one child Eugenia Stevens Smith, being one and the same persons as Mrs. Walton Smith; that for a period of more than twenty years last past she has been acquanted with the following described lands, to-wit:

The Northeast Quarter of Southwest Quarter

The Southeast Quarter of the Northwest Quarter And South Half of Northeast Quarter, less 12 acres along the east side of the Southeast Quarter of the Northwest Quarter in Section 2, Township 20, Range 2 West, containing 148 acres. The Northwest Quarter of the Southeast Quarter less 3 acres in the southeast corner, Section 2, township 20, Range 2 West, containing 37 acres All that part of the west Half of the Northeast Quarter of Southeast Quarter of Section 2, Township 20, Range 2 West, which lies north west of the A B & C Railroad, and containing 8 acres Statuated in Shelby County. Alabama.

Affiant being first duly sworn deposes and says further that there has never been any letters of administration issued on the estate of J. B. Stevens, deceased, and that said estate does not owe any debts.

Stevens, now deceased, your affiant, and the present owner, Mrs. Walton Smith, and those through whom the last named parties hold title to the above described lands, have been, respectively in the open, notorious, continuous, peaceful and adverse possession of said lands, claiming them as their own, respectively, against all the world, and regularly exercising acts of ownership over said lands by using the same for pasture, woodland and cultivating crops thereon; that affiant has hever known or heard the title of the parties named above, or those through whom they hold title to said lands, to be questioned in any way.

Affiant further says that J. B. Stevens and your affiant resided upon said lands and made the same their homestead for a number of years, and that during said time to the present date, your affiant has never heard the possession, ownership or boundaries of said lands to be questioned or disputed in any way.
