KNOW ALL MEN BY THESE PRESENTS, that I, James H. Patterson, of the city of Birmingham, Jefferson County, Alabama, being of sound mind and disposing memory, do hereby make, publish and declare this my last will and testament, in manner and form following:

(1) I direct that all my just debts and funeral expenses be paid as soon after my death as conveniently can be done.

(2) I direct that my executrix, hereinafter named shall pay toward the funeral expenses of my sister, Mattie Walter, the sum of \$250.00, in case my said sister survives me.

(3) I give, devise and bequeath unto my wife, Louise C. Patterson, all property, real, personal or mixed, of which I may die seized or possessed, or to which I may be entitled at the time of my death.

(4) I nominate, constitute and appoint my said wife, Louise C. Patterson, executrix of this will, and expressly direct that she shall not be required to execute any bond or other security for the faithful discharge of her duties in said capacity, and I further direct that she shall not be required to file any inventory or make any report to any court of her acts as such executrix, nor shall she be required to make any final settlement by any court.
