KNOW ALL MEN BY THESE PRESENTS, That in consideration of Thirteen Hundred & no/100 (\$1300.00) Dollars to the undersigned grantor Elizabeth Idella (Della) Moore, a widow, in hand paid by Ocie L. Moore, the receipt whereof is acknowledged I, the said Elizabeth Idella (Della) Moore do grant, bargain, sell and convey unto the said Ocie L. Moore the following described real estate, to-wit:

Beginning at the Northwest corner of the East half of the Northwest Quarter of Section 27, Township 20, Range 1 East and run South along the West line of said 80 200 yards, thence continuing South along said 80 line 79.97 rods, thence East parallel with the North line of said 80 900 feet, thence North parallel with the West line of said 80, to the North line thereof, thence West along the North line of said 80 to the point of beginning, except two acres in the Northwest corner thereof more particularly described as follows: Commence at the Northwest corner of said 80, thence South along the 80 line 200 yards, thence East and parallel with the North line of said 80 to the diagonal line running from the Northwest corner of said 80 to the Southeast corner thereof; thence in a Northwest direction along said diagonal line to the point of beginning, the land herein conveyed, consists of 35 acres, more or less, situated in Shelby County, Alabama. This deed is executed to correct description in deed of grantor's herein to grantee herein, dated the 14th day of September, 1942, and recorded in the Probate Office of Shelby, County, Alabama, in Deed Book 115, at page 264, and is executed in lieu of and to take the place of said deed.

TO HAVE AND TO HOLD , To the said Ocic L. Moore his heirs and assigns forever.

And I do, for myself and for my heirs, executors and administrators, covenant with the said Ocic L. Moore, his heirs and assigns, that I am lawfully seized in fee simple of said premises; that they are free from all incumbrances; that I have a good right to sell and convey the same as aforesaid; that I will, and my heirs, executors and administrators shall, warrant, and defend the same to the said Ocic L. Moore, his heirs and assigns, forever, against the lawful claims of all persons.
