The SWL NEL and 23 acres more or less in the South part of the NWL of NEL in Sec. 34 Tp 18 Range 2 East.

The power company agrees to pay all damages to crops on said lands caused by it during the construction or maintenance of said line, provided, notice of such damage is given the Company within thirty (30) days after such damage accrues however, the grantos, their heirs or assigns shall have no line for the payment of such amounts.

Together with all the right, and privileges necessary or convenient for the full enjoyment or use the of, including the right of ingress and egress to and from said lines; and also the right to cut and keep clear all trees, and to keep clear other obstructions, that may injure or emlanger said lines.

TO HAVE AND TO HOLD the same to the said Company, its successors and assigns for ever.
