PUBLIC IMPROVEMENT SALE DEED

KNOW ALL MEN BY THESE PRESENTS, THAT

WHEREAS, the property hereinafter described was duly assessed by the Town Council of Montevallo Alabama, under Improvement Ordinance # 5 Pro. No. 60; and

WHEREAS, the assessment aforesaid, upon said property, hereinafter described remained due and unpaid and delinquent at the date of the sale thereof, as hereinafter set forth; and,

WHEREAS, the Town Clerk did on October 9, 1942, by virtue of the authority vested in him by law, after giving notice once a week for three successive weeks, viz: September 3, 10, 17, 1942, in The Montevallo, Times, a newspaper published in Montevallo, Shelby County, Alabama, as required by law, at a sale begun and publicly held on said day between the legal hours of sale, offer for sale in front of the United States Post Office in Montevallo, Shelby County, Alabama, the property hereinafter described for the payment of the said assessment and the interest and costs then due and remaining unpaid on said property; and,

WHEREAS at the time and place aforesaid, First National Bank of Birmingham, Alabama, a corporation, bid and offered to pay the sum of Sixteen Hundred Ten and 94/100 Dollars (\$1610.94) being the whole amount of the assessment, interest and cost then due and remaining unpaid on said property and being the highest, best and last bidder for cash, and the said property was sold to First National Bank of Birmingham, Alabama, a corporation, for said price.

NOW THEREFORE, I, C. M. Gardner, as Clerk of the Town of Montevallo, in my official capacity, and for and on behalf of said Town, and for and in consideration of said sum to me as City Clerk in hand paid by said purchaser, the receipt whereof is hereby acknowledged, have bargained, and sold, and I do, as such Clerk, hereby grant, bargain, sell and convey unto the said First National Bank of Birmingham, Alabama, a corporation its executors, administrators and assigns the following described real estate situated in the Town of Montevallo, Shelby County, Alabama, to-wit:

Begin at a point on the south line of Shelby St. 720 ft. southeast from Shelby ' Island St. intersection; thence southwesterly at right angles to Shelby St. to an intersection with Shoal Creek; thence following the creek and its meanderings in an easterly direction to its intersection with the west line of Shelby St.; thence northwesterly along the west and south lines of Shelby St. to the point of beginning.

TO HAVE AND TO HOLD unto the said First National Bank of Birmingham, Alabama, a corporation, its executors, administrators, and assigns, subject, however, to all rights of redemptions as provided by law.
