A certain parcel of land situated in the southwest corner of the northwest quarter of the Northwest quarter of Section 26, Township 21, Range 1 West, and more particularly described as follows: Begin at the southwest corner of the northwest quarter of the northwest quarter of Section 26, thence run north 85 degrees 30 minutes east, 150 feet along the center of the Columbiana Saginaw Cut-Off Road, thence north 72 degrees east 290.6 feet along the middle of said road to a culvert, thence north 11 degrees, 15 minutes west 338.2 feet to the southern line of the Southern Railway right of way, thence south 53 degrees, 50 minutes west along the South Boundary line of said right of way 530.6 feet to the middle of the aforementioned road, thence south 51 degrees, 10 minutes east, 200 feet along the middle of said road to the point of beginning, containing 2.6 acres, more or less, situated in Shelby County, Alabama.
