

WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That in consideration of Thirteen hundred fifty and 00/100 (\$1350.00) ---Dollars to the undersigned grantor The J. F. Pope Company Incorporated in hand paid by D. P. Goswick the receipt whereof is acknowledged the said J. F. Pope Co. Inc. do grant, bargain, sell and convey unto the said D. P. Goswick the following described real estate, to-wit:

The Northwest quarter of the south west quarter (NW $\frac{1}{4}$ of SW $\frac{1}{4}$) of Section (1) Township twenty-one (21), Range One (1) East, except two acres, more or less, sold to John Green on the south side, and one acre, more or less, being thirty five yards wide in south west corner and one hundred and forty (140) yards, long, running north, sold to W. H. Kirkley by T. A. Houston. Also a six-sevenths (6/7) interest in and to the following, viz: one acre more or less described as follows: Commencing at a stake about 127 yards north of the south east corner of the north west quarter (NW $\frac{1}{4}$) of the south west quarter (SW $\frac{1}{4}$) of Section 1 Township 21, Range 1 East, running east 35 yards, thence north 140 yards, thence west 35 yards, thence south 140 yards to place of beginning, containing in all thirty seven and six seventh (36 6/7) acres, more or less. Also one seventh interest in and to the following Commencing at a stake about 127 yards north of the south east corner of the north west quarter (NW $\frac{1}{4}$) of Section 1, Township 21, Range 1 East, running east 35 yards, thence north 140 yards, thence west 35 yards, thence south 140 yards to place of beginning.
