THREE: I do hereby revoke and annul any and all Wills heretofore made by me prior to this date, and any such will, if any, found among my effects shall be null and void and of no effect.

FOUR: I hereby nominate and appoint the said Marvin H. Sandefur as the executor of this will and testament, and do hereby expressly relieve and exempt him from making any bond as such, and also relieve and exempt him from making any inventory or any report to any court of his actions as such.
