SOUNTY OF SHELBY

Rowena B. Barclift and husband W. C. Barclift and Mrs. R. E. Black, a widow for and in consideration of the sum of Twenty Dollars (\$20.00) to us in hand paid by Alabama gower Company, a corporation, the receipt whereof is acknowledged, do hereby grant to said Alabama Power Company, its successors and assigns, the right to construct, operate and maintain electric transmission lines and all telegraph and telephone lines, towers, poles and appliances necessary or convenient in connection therewith from time to time upon, and counter-poise wires or other counter-poise conductors under, a strip of land one hundred feet in width, as said strip is now located by the final lo cation survey thereof heretofole made by said Company, over and across the lands of which it is hereinafter described as being a part, said survey to determine the boundaries of said strip, together with all rights and privileges necessary or convenient for the full enjoyment or use thereof for the purposes above described, including the right of ingress and egress to and from said strip and the right to cut and keep clear all trees and undergrowth and other obstruction on said strip and danger trees adjacent thereto which now or may hereafter injure or endanger any of the works on said strip, and the right to install, maintain and use anchors and guy wires on land adjacent to said strip.

Said strip is a part of a tract of land situated in Shelby County, Alabama, described as follows NWL of SWL of Section One Township 20 South Range 2 East.

Said strip is approximately described as follows: Fifty feet on each side of a line and the continuations thereof; Commence at a point 2031 feet, more or less, East of Southwest corner of said Section One, where the East boundary of right of way of Alabama Power CompanY's Sylacauga-Leeds transmission line intersects the South boundary of said Section One, run thence North 16 deg. no. min. West 2608.1 feet to point of beginning in said NW4 of SW4 of Section One. From said point of beginning run North 62 deg. 28 min. East for a distance of 34 feet, more or less, to East boundary of said NW4 of Section One.

TO HAVE AND TO HOLD the same to the said Company, its successors and assigns, forever.

The grant ors shall have the right to cultivate and use said strip of land for any purpose not inconsistent with the rights which the grantee may from time to time exercise hereunder.
