KNOW ALL MEN BY THESE PRESENTS, that the undersigned Buffalo Rock Company, a corporation, for and in consideration of the sum of Fifty Dollars to it in hand paid by Alabama Power Company, a corporation, the receibb whereof is acknowledged, does hereby grant to said Alabama Power Company, its successors and assigns, the right to construct, operate and maintain electric transmission lines and all telegraph and telephone lines, towers, poles and appliances necessary or convenient in connection therewith, from time to time upon, and counter-poise wires or other counter-poise conductors under, a strip of land one hundred feet in width, as said strip if now located by the final location survey thereof heretofore made by said Alabama Power Company, over and across the lands of which it is hereinafter described as being a part said survey to determine the boundaries of said strip, together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof for the purposes above described, including the right of ingress and egress to and from said strip and the right to cut and keep clear all trees and undergrowth and other obstruction on said strip and danager trees adjacent thereto which now or may hereafter injure or endanger any of the works on said strip, and the right to install, maintain and use anchors and guy wires on land adjacent to said strip.

Said strip is a part of a tract of land situated in Shelby County, Alabama, described asfollows: SWE of NEE of Section One Township 20 South Range 2 East.

Said strip is approximately described as follows: Fifty feet on each side of a line and the continuations thereof; Commence at a point 2031 feet, more or less, East of Southwest corner of said Section One, where the East boundary of right of way of Alabama Power Company's Sylacauga -Leeds transmission line intersects the South boundary of said Section One, run thence North 16 deg. no min. West 2608.1 feet to a point in N號 of S號 of said Section One, run thence North 62 deg. 28 min. East for a distance of 1549 feet, more or less, to a point on the East boundary of SEE of NWE of said Section One, which is the point of beginning. From said point of beginning, run thence North 62 deg. 28 min. East for a distance of 1520 feet, more or less, to a point on the East boundary of said SWh of NEh of Section One.

TO HAVE AND TO HOLD THE SAME TO the said Alabama Power Company, its successors and assigns, forever. The grantor shall have the right to cultivate and use said strip of land for any purpose not inconsistent with the right which the grantee may from time to time exercise hereunder.
