Albert Datcher and wife Ruth Belle Datcher for and in consideration of the sum of Seventy Dollars (\$70.00) to us in hand paid by Alabama Power Company, a corporation, the receipt where of is acknowledged, do hereby grant to said Alabama Power Company, its successors and assigns, the right to construct, operate and maintain electric transmission lines and all telegraph and telephone lines, towers, poles and appliances necessary or convenient in connection therewith from time to time upon, and counter-poise wires or other counter-poise conductors under, a strip of land one hundred feet in width, as said strip is now located by the final location survey thereof heretofore made by said Company, over and across the lands of which it is hereinafter described as being a part, said survey to determine the boundaries of said strip, together with all rights and privileges necessary or convenient for the full enjoyment or use thereof for the purpose above described, including the right of incress and egress to and from said strip and the right to cut and keep clear all trees and undergrowth and other obstruction on said strip and danger trees adjacent thereto which now or may hereafter injure or endanger any of the works on said strip, and the right to install, maintain and use anchors and guy wires on land adjacent to said strip.

Said strip is a part of a tract of land situated in Shelby County, Alabama, described as follows:

NET of NWT and 20 acres more or less, on SW side of NWT of NET of Section 36 T19 S R 2 East.

See deed recorded in Volume 110 page 109 in Probate records of Shelby County, Ala.

Said strip is approximately described as follows: Fifty feet on each side of a line and the continuations thereof; Commence at a point 2299.9 feet, more or less, West of Northeast corner of Section 35 T 19 S R 2 E, where the East boundary of right of way of Alabama Power Company's Sylacauga-Leeds transmission line intersects the North boundary of said Section 35

run thence South 23 degrees 27 minutes East 1678.2 feet to a point in SW<sup>1</sup>/<sub>4</sub> of NE<sup>1</sup>/<sub>4</sub> of said Section 35, run thence North 79 degrees 53 minutes East 2393.7 feet, more or less, to an iron pipe, which is an angle point. From said angle point run South 88 degrees 52 minutes East 619 feet, more or less, to West boundary of NE<sup>1</sup>/<sub>4</sub> of Ne<sup>1</sup>/<sub>4</sub> of Section 36 T 19 S R 2 E, which is the point of beginning. From said point of beginning run on the same bearsing of South 88 degrees 52 minutes East 2686.9 feet, more or less, to East boundary of NW<sup>1</sup>/<sub>4</sub> of NE<sup>1</sup>/<sub>4</sub> of Section 36 T 19 S R 2 E.

TO HAVE AND TO HOLD the same to the said Company, its successors and assigns, forever.

The grantors shall have the right to cultivate and use said strip of land for any purpose not inconsistent with the rights which the grantee may from time to time exercise hereunder.
