A strip of land 66 feet wide lying 33 feet on each side of the centerline of proposed State project 396. Beginning at station 183/50 and running a distance of 1350 feet along said centerline to station 197/00 as now staked out by the State Highway Engineer. The said strip of land contains 2.05 acres, more or less, and lies in the SW4 of SW4 of Section 28, Township 18 South, Range 2 East, Shelby County, Alabema.
