

Right of way deed for public road

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned T. W. Porter and wife Mattie E. Porter of the County and State aforesaid, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County, the receipt whereof is hereby acknowledged, and for the further consideration of the benefits accruing to us and to the public from the construction of a public road through our lands, we do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a right of way hereinafter described, over and across the lands of the undersigned in Shelby County, Ala., for a public road; Which right of way shall be 30 feet in width or 15 feet in width on each side of the center line of the said road, as it is now located and staked out by the State Highway Department, or as much of our lands as is required to make a 30 foot right of way, across our lands which are located and described as follows, to-wit:

30 feet off of west side of that part of NW¹/₄ of SW¹/₄ lying North of Montgomery road.

This part of road is to be built as staked out by Porter.

and for and in consideration of the benefit to our property by reason of the construction of said road, we hereby release the county from all consequential damages, present or prospective to our property, arising out of the construction, maintenance or repair of said road, and that said road is a benefit to our property is hereby admitted and acknowledged.
