

Right of Way Deed for Public Road

SHELBY COUNTY. )

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, Will A. Stone and wife, Marjorie Stone of the County and State aforesaid, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County, the receipt whereof is hereby acknowledged, and for the further consideration of the benefits accruing to us and to the public from the construction of a public road through our lands, we do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a right of way herein-after described, over and across the lands of the undersigned in Shelby County, Ala., for a public road; Which right of way shall be        feet in width or        feet in width on each side of the center line of the said road, as it is now located and staked out by the State Highway Department, or as much of our lands as is required to make a        foot right of way, across our lands which are located and described as follows, to-wit:

A strip of land 30 feet wide, Beginning at Midway Filling Station and extending to the line of Tine Merrell's land where said land crosses the main track of the Southern Railway and intersects the land this day granted by the said Tine Merrell.

It is understood and agreed that in the event said strip of land shall ever be discontinued or abandoned for use as a right of way as herein contemplated, then the same shall revert to the Grantor herein without notice.

and ~~for~~ and in consideration of the benefit to our property by reason of the construction of said road, we hereby release the county from all consequential damages, present or prospective to our property, arising out of the construction, maintenance or repair of said road, and that said road is a benefit to our property is hereby admitted and acknowledged.
