Gorman and wife Ada Gorman of the County and State aforesaid, in and for the consideration of \$125.00 in hand paid by Shelby County, the receipt whereof is hereby acknowledged, and for the further consideration of the benefits accruing towns and to the public from the construction of a public road through our lands, we do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a right of way hereinafter described, over and accrss the lands of the undersigned in Shelby County, Ala., for a public road; Which right of way shall be 66 feet in width or 35 feet in width on each side of the center line of the said road, as it is now located and staked out by the State Highway Department, or as much of our lands as is required to make a 66 foot right of way, across our lands which are located and described as follows, to-wit:

A strip of land 33 feet wide lying on the left of the centerline of state project 331 A as now staked out by the State Highway Dept. of Alabama. beginning at station 937 plus 84 thence to station 938 plus 20 where said strip becomes 66 feet wide lying 33 feet on each side of said centerline thence to station 952 plus 00 where said strip of land ends. Also a strip of land 66 feet wide lying 33 feet on each side of said centerline beginning at station 966 plus 36 and ending at station 968 plus 00.
