AFFIDAVIT

Before me, the undersigned authority in and for said County and said State, personally appeared W. A. Ledbetter who, after first being by me auly sworn to speak the truth deposes and says:

I am a son of 0. G. Ledbetter and his wife, Minnie Ledbetter; both died intestate. 0. G. Ledbetter having died March 28, 1925 and Minnie Ledbetter having died September 11, 1931.

On January 7, 1932, their sole and surviving heirs at law were: Affiant, W. A. Ledbetter whose wife is Caddie Ledbetter; Ollie Ledbetter, unmarried; L. E. Ledbetter, whose wife is Orlevia Ledbetter, sometimes known as M. A. Ledbetter; Belle Doss, whose husband is Frank Doss; J. L. Ledbetter, whose wife is Virgie Ledbetter; V. B. Ledbetter, whose wife is Rhoda Ledbetter; Beatrice Key, whose husband is Cleve Key, sometimes known as G. C. Key; Minnie Tidwell, whose husband is John Tidwell, sometimes known as John H. Tidwell.

On January 7, 1932, all of the above named persons met before W. H. Boyce, a Justice of the Peace and executed deeds to each other, dividing the real estate which we had inheritied upon the death of our father and mother. I notice in the deed dated January 7, 1932 to Ollie Ledbetter from the above said persons that the Justice of the Peace wrote the names Cleve Ledbetter and Beatrice Ledbetter in the acknowledgement whereas he should have written the names Cleve Key and Beatrice Key. I have never heard of a Cleve Ledbetter or a Beatrice Ledbetter. In the same acknowledgement the Justice of the Peace wrote the name John Tidwell twice whereas he should have written John Tidwell and wife, Minnie Tidwell.

My father, 0. G. Ledbetter took possession of No of NW of SW of Section 18, Township 20, Range 3 West, Shelby County, Alabama in the year 1908 and lived on it and cultivated parts of it each and every year until his death. My sister, Ollie Ledbetter, has lived on the property since then and has obtained fire wood and building timbers from it each and every year until this very day. I have never known of anyone other than those in possession of it who claimed title to it.
