KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of ONE DOLLAR to the undersigned, Vivian Finley, a widow, in hand paid by James Dewey Finley, the receipt whereof is hereby acknowledged, I do remise, release, quit claim and convey to the said James Dewey Finley all my right, title, interest and claim in and to the following described real estate, situated in Shelby County, Alabama, to-wit:

The Southeast Quarter of the Northeast Quarter of Section 4, Township 22, Range 2 West, containing 40 acres, more or less.

Also, all that part of the Southwest Quarter of the Northeast Quarter of Section 4, Township 22, Range 2 West, lying East of the right of way of the Birmingham and Montgomery Highway, and containing 4.27 acres, more or less.

Also, eleven acres of equal width off of the North side of the Northeast Quarter of the Southeast Quarter of Section 4, Township 22, Range 2 West, and being a strip of land 363 feet in width of equal distance across the North side of said Northeast Quarter of the Southeast Quarter of said Section 4, and containing eleven acres, more or less.

Also, two acres of land in the Northeast corner of the Northwest Quarter of the Southeast Quarter of Section 4, Township 22, Range 2 West, lying East of the right of way line of the Birmingham and Montgomery Highway and described as follows: Beginning at the Northeast corner of said Northwest Quarter of the Southeast Quarter of said Section 4, and run thence South 363 feet to a point; run thence West to the Eastern margin of the right of way of said Birmingham and Montgomery Highway; run thence in a Northern direction along the East right of way line of said Highway to where the same intersects the North line of said Northwest Quarter of said Southeast Quarter of said Section 4; run thence East to the point of beginning and containing 2 acres, more or less.

TO HAVE AND TO HOLD TO THE SAID James Dewey Finley, his heirs and assigns forever.


