KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of ONE DOLLAR and other valuable /considerations, to the undersigned Grantor, J.M. Lyon, a widower, in hand paid by H.R. Lyon and wife, Lola Lyon, the receipt whereof is hereby acknowledged, I, the said J.M. Lyon, a widower, do grant, bargain, sell amd convey unto the said H.R. Lyon and wife, Lola Lyon, the following described real estate, to-wit:

The Southeast Quarter of the Northeast Quarter of Section 7, Township 21 Range 1 East.

Also, that part of the Southwest Quarter of the Northeast Quarter of Section 7, Township 21, Range 1 East, which lies East of the Columbiana and Wilsonville Highway, and North of a Branch running in a Southeasterly direction crossing the South line of the South Half of the Northeast Quarter of said Section 7, near the Southeast corner of said Southwest Quarter of the Northeast Quarter and known as the Dollar Branch. Also, that certain tract of land commencing at a point on the West right of way line of the Columbiana and Wilsonville Highway, about 50 feet West of the Northeast corner of the Southwest Quarter of the Northeast Quarter of Section 7, Township 21, Range 1 East, and running thence in a Southwesterly direction along the West line of said Highway, a distance of 402 feet for a point of beginning of the tract of land herein conveyed: Run thence in a Northwesterly direction a distance of 365 feet, more or less, to the North line of said Southwest Quarter of the Northeast Quarter; run thence West along the North line of said forty acre tract, a distance of 518 feet, more or less to a small branch; run thence in a Southerly direction along the meanderings of said branch, and crossing the Chelsea Public road, 700 feet, more or less, to the Northwest right of way line of said Columbiana and Wilsonville Highway, near the West line of said Southwest Quarter of the Northeast Quarter; run thence in a Northeasterly direction along the Northwest side of the Columbiana and Wilsonville Highway, a distance of 650 feet, more or less, to the point of beginning of the tract herein conveyed, containing in all 67 acres, more or less, herein conveyed.
