

POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, That, I, Etta Harper , now of Chelsea, County of Shelby, State of Alabama, but formerly of Natchez, Mississippi, do hereby constitute and appoint my nephew,,Roy Harper,, of Chelsea, Shelby County, Alabama, a true and lawful attorney for me, and in my name and behalf to act generally as my attorney, in all matters and things in which I may be interested or concerned, and to collect all debts or demands, and to recover and receive all monies and debts belonging , due, or which may become due, from any and all persons or persons or corporations whatsoever, to draw checks, or drafts for the payment of money now on deposit in my name in Britton & Koontz National Bank, at Natchez, Mississippi, and City Bank & Trust Company at Natchez, Mississippi, and said banks are hereby authorized to honor and pay the same; and to take into possession and endorse, sell, set-over and deliver any and all stocks, bonds, or choses in action now owned and held by me, all for the use of and in payment of all expenses of my maintenance, support, care, comfort, doctors' bills, hospital bills, together with any and all expenses thereto, together with all expenses incurred by my said attorney incident to the handling of the affairs of my estate, which my said attorney may deem necessary or expedient for my comfort and the proper administration of the assets of my estate during my natural life, and such necessity or expediency, I leave to the sole discretion and decision of my said attorney, giving and granting unto my said attorney full power and authority to do and perform all the acts necessary and proper to effectuate all or any part of the premises; hereby ratifying and confirming whatsoever my said attorney shall and may do in the premises by virtue hereof.
