All that part of NE 4 of NW 4 of Section 26, Township 21, Range 3 lying east of Montevallo- Ashville Public Road.

Also all that part of N² of S ² of NE ⁴ of Section 26, Township 21, Range 3 lying North of the line fence of Elliott and Robertson

Together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including the right of ingress and egress to and from said lines; and also the right to cut and keep clear all tress, and to keep clear other obstructions, that may injure or endanger saidlines.
