The South half ($S\frac{1}{2}$) of North West fourth ($NW\frac{1}{4}$) of South west fourth, ($SW\frac{1}{4}$) of Section Six (6) Township twenty-two (22) Range one (1) East. Subject to any and all existing rights of Way.

TO HAVE AND TO HOLD: To the said Eddie Bouie, his heirs and assigns, forever. And I do, for myself and for my heirs, executors and administrators, covenant with the said Eddie Bouie he irs and assigns, that I lawfully seized in fee simple of said premises; that they are free from all encumbrances; that I have a good right to sell and convey the same as aforesaid; that I will, and my heirs, executors and administrators shall warrant and defend the same to the said Eddie Bouie heirs and assigns forever, against the lawful claims of all persons.
