Alverson and wife Verna Ruth Alverson for and in consideration of the sum of One and no/100 Dollars (\$1.00) to us in hand paid by Alabama Power Company, a corporation, the receipt whereof is acknowledged, do hereby grant to said Alabama Power Company, its successors and assigns, the right to construct, operate and maintain its lines of poles and towers and appliances necessary in connection therewith as located by the final location survey heretofore made by said Company, for the transmission of electric power with the right to string thereon from time to time electric power and telephone wires and the right to permit other corporations and persons to attach wires to said poles and towers upon, over and across the following described lands situated in Shelby County, Alabama:

Commencing at the SW corner of the SE⁴ of SE⁴ of Section 20, Township 19, Range 1 East, run east 210 feet for a point of beginning; run thence north 50 feet, more or less to a point on the south boundary of the Florida Short Route Highway, run thence east along the south boundary of said highway 450 feet to a point; run thence south 44 feet more or less, to a point of the south boundary of SE⁴ of SE⁴ of said section 20; run thence west 450 feet, more or less to point of beginning.

Together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including the right of ingress and egress to and from said lines; and also the right to cut and keep clear all trees, and to keep clear other obstructions, that may injure or endanger said lines.
