KNOW ALL MEN BY THESE PRESENTS, That I, Thomas F. Vest, being over the age of twenty-one years, of sound mind and disposing memory, do hereby make, publish and declare this to be my last will and testament hereby revoking all former wills heretofore by me made.

I desire that the expenses of my last illness and funeral, and all my just debts be paid by my Executrix, hereinafter named, as soon after my decease as is convenient.

SECOND
