DEED

THIS INDENTURE, made and entered into on this the 15th day of Sept., 1943, by and between the undersigned, Thelma Walker Lee, and husband, Joe Lee; Edna Walker Tinney, and husband, Ocie Tinney; Marie Walker Hughes and husband, Hal Hughes, and Irene Walker, being the heirs-at-law and next of kin of W. R. Walker, deceased, party of the first part; and Minnie Walker, being the widow of W. R. Walker, deceased, party of the second part,

WITNESSETH:

That the said party of the first part, for and in consideration of the sum of ONE DOLLAR (\$1.00) and other valuable considerations, in hand paid to them by the part of the second part, the receipt whereof is hereby acknowledged, has granted, bargained, and sold and by these presents does grant, bargain, sell and convey unto the said party of the second part her heirs and assigns the following described real property, situated, lying and being in the County of Shelby, State of Alabema, to-wit:

A part of Section 24, Township 20, Range 3 West, more particularly described as follows: Beginning at a point in the west right of way line of the highway leading from Birmingham to Montgomery, which point is the Southeast corner of the lot now owned by T. S. Baker and from said point of beginning run South 72 degrees and 30 minutes West 158 feet,

run thence South 9 degrees East 225 feet along the East line of old highway right of way, run thence North 72 degrees and 30 minutes East 203 feet, run thence North 19 degrees and 30 minutes West 228 feet to the point of beginning, containing 3/4 of an acre, more or less, and bounded on the East by the Montgomery and Birmingham Highway right of way, and on the North by the T. S. Baker lot, and on the West by the old Birmingham and Montgomery Highway, and on the South by lands of Sallie E. Cost, being the lands formerly owend by A. W. Cost, now deceased.

Also a part of the Southwest Quarter of the Southwest Quarter of Section 24,
Township 20, Range 3 West, beginning at a stake on said Section line where said

Right of Way crosses, and run with said Right of Way North 19 degrees and 30
minutes West a distance of 220 feet for a point of beginning: Run thence South 88
degrees and 30 minutes East 420 feet; run thence South 19 degrees and 30 minutes
East 210 feet to said Section line; run thence with said Section line South 88 degrees
and 30 minutes East 210 feet; thence leaving said Section line and running North
19 degrees and 30 minutes West 430 feet; run thence South 89 degrees and 50 minutes
West 630 feet to the Birmingham and Montgomery Highway Right of Way; and running
thence with said Right of Way South 19 degrees and 30 minutes East 210 feet to the
point of beginning and containing 4 acres.

- Also a tract of land in the Southwest Quarter of Section 24, Township 20, Range 3
 West, described as follows: For a point of beginning run North 18 degrees West 10
 feet from where the East boundary line of the Birmingham and Montgomery Highway Right

 run thence North 88 degrees West 6.42 chains to a stake on the East side of said
 Highway Right of Way; run thence South 18 degrees East, a distance of 210 feet, more
 or less, along the East side of said Highway to the point of beginning, and containing
 2 acres.
- Also that part of the Southwest Quarter of Section 24, Township 20, Range 5 West, described as follows: Beginning at the Southeast corner of the Southwest Quarter of said Section 24, Township 20 Range 5 West, and run thence North along the East boundary line of said Southwest Quarter, a distance of 653.7 feet; run thence at an angle of 89 degrees and 19 minutes to the left, a distance of 1442.5 feet; run thence at an angle of 107 degrees and 20 minutes to the left, a distance of 472 feet; run thence at an angle of 72 degrees and 40 minutes to the left 186.6 feet; run thence at an angle of 72 degrees and 40 minutes to the right 220.4 feet; run thence at an angle of 74 degrees and .01 minutes to the left 1062 feet to the point of beginning and containing 19.3 acres.

The tracts of land described in the last three preceding paragraphs are the same lands described in deed from Alfred H. Housden and wife, Kate V. Housden to W. R. Welker and wife, M. A. Welker, and dated January 30, 1943, and recorded in Deed Book 114, on page 328, in the office of the Judge of Probate of Shelby County, Alabama, and being the same lands conveyed from A. W. Cost and wife, S. E. Cost to Alfred H. Housden and Kate V. Housden, and also conveyed by Sallie E. Cost to the above named Alfred H. and Kate V. Housden.

There is excepted, however, from the above conveyance 7 acres of land, more or less, heretofore conveyed by the parties hereint to George M. Walker, which is described in that certain deed from the parties hereinto George M. Walker, dated July, 1943.
