by the final location survey heretofore made by said Company, for the transmission of electric power with the
right to string thereon from time to time electric power and telephone wires and the right to permit other
corporations and persons to attach wires to said poles and towers upon, over and across the following described
lands situated in Shelby County, Alabama:

Begin at the South East corner of the NE4 of NE4 of Sec. 3, Tp. 22, R 4 W and runing along the south forty line 660 feet, then due North 329 feet this being the beginning point of said tract, thence going on due North 333 feet, then East 302 feet, thence South 415 feet, then West 210 feet to point of beginning.

Together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including the right of ingress and egress to and from said lines; and also the right to cut and keep clear all trees, and to keep clear other obstructions, that may injure or endanger said lines.
