Farr and wife Mary Farr for and in consideration of the sum of One & No/100 Dollars (\$1.00) to us in hand paid by Alabama Power Company, a corporation, the receipt whereof is acknowledged, do hereby grant to said A labama Power Company, its successors and assigns, the right to construct, operate and maintain its lines of poles and towers and appliances necessary in connection therewith, as located by the final location survey heretofore made by said Company, for the transmission of electric power with the right to string thereon from time to time electric power and telephone wires and the right to permit other corporations and persons to attach wires to said poles and towers upon and across the following described lands situated in Shelby County, Alabama:

Part of the NEE of Swa of Sec. 18, Tp. 22, R 1 E described as follows, begin at the North West corner of SE of NW of Sec. 18, thence run south 30 30 East along west boundary of said S時 of NW and along west boundary of said NE of SW 1834.2 feet, then turn an angle of 75° 00' to the left in a Southeasterly direction 127.0 feet for point of beginning of the tract of land herein described, then turn an angle of 230 30° to the right southerly 453.2 feet, then turn an angle of 1220 15' to the left North East 287.3 feet, then turn an angle of 30 30 to the right northeast 197.6 feet, then turn an angle of 830 45 to the left northwest 415. feet, then turn an angle of 1030 51 to the left southwest 319.4 feet to point of beginning.

Together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including the right of ingress and egress to and from said lines; and also the right to cut and keep clear all trees, and to keep clear other obstructions, that may injure or endanger said lines.
