Transmission Line Permit

We, W. H. Nabors & wife Mrs. W. H. Nabors for and in consideration of the sum of One Dollar (\$1.00) to us in hand paid by Alahama Power Company, a corporation, the receipt whereof is acknowledged, do hereby grant to said Alabama Power Company, its successors and assigns, the right to construct, operate and maintain its lines of poles and towers and appliances necessary in connection therewith, as located by the final location survey heretofore made by said Company, for the transmission of electric power with the right to string thereon from time to time electric power and telephone wires and the right to permit other corporations and persons to attach wires to said poles and towers upon, over and across the following described lands situated in Shelby County, Alabama:

Begin at NE corner of NN of NE of Section 29, and run South to SE corner, thence South 206 feet thence South 54 degrees 48 minutes west 877.8 feet, thence South 89 degrees 35 minutes West 213 feet, thence North 44 deg. 35 minutes West 134.2 feet, South 86 degrees 35 minutes west 226.8 feet to west line of SWa of NET, thence north 3 degrees 50 minutes East 208 feet 8 inches; thence North 736.6 feet; thence North 60.5 ft. to Florida Short Route, thence East along highway to east line of SW of SE of Section 20, thence to point of beginning being 56 acres more or less and being in SWA of SEA of Section 20 & NWA of NEA of Section 29: all in Tp. 19, Range 1 East.

Together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including the right of ingress and egress to and from said lines; and also the right to cut and keep clear all trees, and to keep clear other obstructions, that may injure or endanger said lines.
