KNOW ALL MEN BY THESE PRESENTS, That I, E.C. Burton, do hereby constitute and appoint my wife, Annie M. Burton, of the County of Shelby, State of Alabama, my true and lawful attorney, for me, and in my name and behalf to grant, bargain, sell and convey for a valuable consideration, to be by my said Attorney in Fact fixed, in fee simple, and/ or the timber situated thereon, to be determined by said Attorney in Fact the following described real estate situated in Shelby County, Alabama, to-wit:

The West Half of the Northwest quarter of Section 13, Township 22, Range 2 West, East of old Columbiana, and Calera, Road.

The Southwest quarter, North of Shelby Iron Company road, EXCEPT forty acres on the East side and FIVE acres heretofore sold in Section 13, Township 22, Range 2 West.

The North Half of the Southeast quarter of Section 14, Township 22 Range 2 West.

Southwest quarter of the Southeast quarter North of Highway in Section 14, Township 22, Range 2 West.

The Southeast Quarter of the Southeast Quarter lying Northeast of the road running from the Highway at the Southern Railroad crossing to intersection of Shelby Iron Company road in Section 14, Township 22, Range 2 West.
