KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of One & 00/100 Dollars to C. L. Guyton and wife, Rachel Guyton in hand paid by M. M. Melson the receipt whereof is hereby acknowledged we do remise, release, quit claim and convey to the said M. M. Melson all our right, title, interest, and claim in or to the following described real estate, to-wit:

A part of the Southeast Quarter of Northwest Quarter (SE $\frac{1}{4}$ of NW $\frac{1}{4}$) of Section 36, Township 19, South Range 3 West, more particularly described as follows: Begin at Southeast corner of the Southeast Quarter of the Northwest Quarter of said section 36; thence North 2⁰ 56' West thirteen hundred and twenty-one and 7/10 (1321.7) feet to stake at intersection of fence lines; thence South 89⁰ 34' West five hundred and seventy-three and 4/10 (573.4) feet to stake at intersection of wire fences; thence South 29⁰ 37' West eight hundred, nineteen and no/10/feet to a stake at fence line; thence South 59⁰ 26' East eleven hundred and ninety-four and No/10 (1194,0) feet to beginning, containing 20 acres, more or less, situated in Shelby County, Alabama.
