SATISFACTION, RELEASE AND DISCHARGE, made this 5th day of May, 1944, by Chemical Bank & Trust Company, a corporation organized and existing under the laws of the State of New York, and having its principal office at 165 Broadway, New York, New York (hereinafter sometimes called the Corporate Trustee) and Howard B. WHEREAS, the resolution adopted by the Board of Directors of the Corporation on January 27, 1936, creating the Corporation's General Mortgage 42 % Bonds, Series B, provides that the Corporation, may, at its election, redeem all of such Series B Bonds at any time after January 31, 1941; and

WHEREAS, the resolution adopted by the Board of Directors of the Corporation on November 9, 1936, creating the Corporation's General Mortgage 42% Bonds, Series C, provides that the Corporation may, at its election, redeem all of the Series C. Bonds at any time after October 31, 1941; and

WHEREAS, the Series B Bonds and the Series C Bonds are the only bonds now issued and outstanding under said General Mortgage; and

WHEREAS, said General Mortgage provides that, on deposit with the Corporate. Trustee of the amount necessary to redeem all of the bords outstanding and on delivery to the Corporate Trustee of proof satisfactory to the Corporate Trustee that arrangements have been made insuring to the satisfaction of the Corporate Trustee that notice of redemption will be published as provided in said General Mortgage and on payment to the Trustees of their costs, charges and expenses in relation thereto or otherwise under the General Mortgage, the Trustees shall, upon the request of the Corporation, cancel and satisfy said General Mortgage and cause the same to be released and dispharged of record in all places where it shall have been recorded, and shall assign or cause to be assigned and shall deliver to the Corporation or upon its order all securities and moneys then held by the Corporate Trustee, except the moneys deposited with the Corporate Trustee for the redemption of the outstanding bonds; and

WHEREAS, the Corporation has deposited with the Corporate Trustee the amount necessary to pay and redeem all of the outstanding General Mortgage $4\frac{1}{2}\%$ bonds, Series B, and all of the outstanding General Mortgage $4\frac{1}{2}\%$ Bonds, Series C, not theretofore paid or redeemed or otherwise retired or cancelled, plus

an amount sufficient to pay all interest thereon not the retofore paid and maturing on or before the respective redemption dates thereof, and has delivered to the Corporate Trustee irrevocable authority, satisfactory to the Corporate Trustee, to call all of said outstanding General Mortgage 42% Bonds, Series B and Series C, for redemption and to cause notices of such redemption to be published as provided in the General Mortgage; and:

WHEREAS, the Corporation has also paid or caused to be paid to the Trustees all of their costs, charges, and expenses in relation thereto or otherwise under the General Mortgage or has made provision satisfactory to the Trustees for the payment thereof; and

WHEREAS, the Corporation is nowentitled to have the General Mortgage, the First Supplemental Indenture, the Second Supplemental Indenture, the Third Supplemental Indenture, the Fourth Supplemental Indenture, the Fifth Supplemental Indenture and the Sixth Supplemental Indenture released and cancelled;

NOW, THEREFORE, said Chemical Bank & Trust Company and Howard B. Smith, Trustees, for and in consideration of the premises and by Firtue and in pursuance of the power and authority conferred upon them by said General Mortgage have this day remised, released, conveyed and assigned, and do by these presents remise, release, convey and assign, and do forever quit-claim unto the said Republic Steel Corporation, its successors and assigns, forever, all their right, title and interest as such Trustees in and to the land, property, premises, interests, rights and securities described in said General Mortgage dated September 1, 1935, and in said First Supplemental Indenture dated May 26, 1937, and in said Second Supplemental Indenture dated November 1, 1937, and in said Fourth Supplemental Indenture dated April 1, 1938, and in said Fifth Supplemental Indenture dated October 2, 1939, and in said Sixth Supplemental Indenture dated November 5, 1943.

TO HAVE AND TO HOLD the same with all the appurtenances #ereunto belonging free and clear and discharged of and from all liens, encumbrances and claims under and by virtue of said General Mortgage, said First Supplemental Indenture, said Second Supplemental Indenture, said Third Supplemental Indenture, said Fourth Supplemental Indenture, said Fifth Supplemental Indenture and said Sixth Supplemental Indenture or any of them. The said Trustees certify and acknowledge that said General Mortgage dated September 1, 1935 (Including said six Supplemental Indentures), and the indebtedess secured thereby are fully paid and satisfied and that said General Mortgage, said First Supplemental Indenture, said Second Supplemental Indenture, said Third Supplemental Indenture, said Fourth Supplemental Indenture, said Fifth Supplemental Indenture, said Sixth Supplemental Indenture, and each of them, and the lien created thereby, are cancelled, released and discharged and do hereby consent that said General Mortgage, said First Supplemental Indenture, said Second Supplemental Indenture, said Third Supplemental Indenture, said Fourth Supplemental Indenture, said Fifth Supplemental Indenture, sad said Sixth Supplemental Indenture, and each of them, may be discharged of record and said Trustees authorize and direct the respective recording officers of the jurisdictions in which said General Mortgage, said First Supplemental Indenture, said Second Supplemental Indenture, said Third Supplemental Indenture, said Fourth Supplemental Indenture, said Fifth Supplemental Indenture, and said Sixth Supplemental Indenture, are respectively recorded, to note the discharge of the same upon the record thereof.
