Item 1. I will and direct that all my just debts and funeral expenses shall be paid by my executor as soon after my decease as practicable.

Item 2. I give, devise and bequeath to my beloved wife Exa T. Robinson all the net income from all of my property of every kind and description and wherever located, as long as she lives and at her death, I desire that all of my property be divided equally to my three children, Thomas F., Joe H. and W. Lewis Robinson.

Item 3. I nominate and appoint my son, Thomas F. Robinson as executor of this, my last will and testament; and I hereby declare that my said son shall not be required to give any bond for the performance of any duties arising hereunder, nor to make any settlement or report to any court of proceedings hereunder.
