This cause coming on to be heard upon the report of Wade Morton and George Rogers, who were heretofore on the 8th day of May, 1944, appointed Commissioners to make a full and complete inventory and appraisal of the real estate and personal property belonging to Henry C. Fulmer, Deceased, and to set apart the same as exempt to Mrs. Eula S. Fulmer, the widow of said decedent, which said report was filed in this Court on the 9th day of May, 1944, and set for hearing on this day.

And it appearing to the Court that no exceptions or objections have been filed to said report and that the time allowed by law for filing same has expired; and it further appearing to the court that notice of the filing of said report and of the day set for hearing the same has been given as directed by law, and the former, order of this Court made and entered in this cause on the 9th day of May, 1944; and it appearing to the Court from said report and from the evidence submitted that said decedent was a resident of Jefferson County, Alabama, at the time of his death, and that said real estate hereinafter described was all the property owned by said decedent and that said property is less in value and area than the exemptions allowed by law to the widow and minor children or either of them; and it further appearing to the Court that said decedent left no minor child or children and that said Commissioners did set apart the real estate to the widow of said Henry C. Fulmer, Deceased, as exempt to her ad provided by law. It is therefore,

ORDERED, ADJUDGED AND DECREED by the Court that said report of Commissioners be and the same is hereby in all things ratified and confirmed and that said real estate as follows, to-wit:

An undivided one-half interest in and to the following described property, situated in Shelby County, Alabama, The Southwest quarter of Northeast Quarter (SW $\frac{1}{4}$ of NE $\frac{1}{4}$) and the Northwest Quarter of Southeast Quarter (NW $\frac{1}{4}$ of SE $\frac{1}{4}$) of Section 11, Township 24, Range 13 East in Shelby County, Alabama, subject to easement granted to Alabama Power Company by deed recorded in the Probate Office of said County in Deed Book 102, page 364.

that being all the property owned by said decedent at the time of his death, be and the same is hereby set apart as exempt to Mrs. Eula S. Fulmer, the widow of said decedent, the title to said real estate shall vest absolutely in said widow. It is further ordered that petitioner pay the costs of this proceeding, for which execution may issue.
